Dear Residents, Family Members and Responsible Parties,

It's hard to imagine that it's been over a month since our last update, during which time we have remained COVID-19 free.

However, this week we were notified that one of our staff members tested positive for the coronavirus, due to exposure, and has been asymptomatic. This person has not worked in the facility since July 24 and will be quarantined at home for 14 days and be symptom free for the three days prior to returning to work.

Although some restrictions are starting to be lifted in the community, the virus continues to be present. So we want to remain vigilant and we continue to remind everyone to do frequent handwashing, wear your masks, and practice social distancing. Residents and staff are still screened and have their temperature taken every day. Visitors are still not allowed and Residents are to go out only for essential appointments. All this is to help keep our Residents, staff and Sisters safe and healthy.

We are working on a reopening plan which needs to be submitted and approved by the state. In order for the reopening plan to go into effect, we have to be virus free for 14 days, so we want to work hard to keep our Residents, staff and Sisters safe and healthy by continuing to follow the above practices.

We know the no visitors policy has been very hard on both our Residents and their families. We would like to offer the opportunity of 15 minute *drive-by visits*, where you would come to the Home, you would stay in the car and we will have the Resident seated outside, six feet away from your car, and you can have a little chat. Both you and the Resident must wear face masks.
